**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
POWER DESIGN MISSION CRITICAL, LLC**

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Power Design Mission Critical, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:

1. The name of the company is Power Design Mission Critical, LLC.
2. The Articles of Organization of the Company were filed with the office of the Florida Department of State on July 30, 2013, with an effective date of August 1, 2013, and amended on February 11, 2014. The Company was assigned document number L13000108284.
