ARTICLES OF ORGANIZATION

OF

ROBOTIC CRITICAL CARE SERVICES, PLLC

The undersigned person adopts the following Articles of Organization for Robotic Critical Care Services, PLLC (the "Company") under the Florida Limited Liability Company Act and the Professional Service Corporation and Limited Liability Company Act:

- 1. Name. The name of the Company is Robotic Critical Care Services, PLLC.
- 2. Registered Office and Agent. The Company's initial registered office is 390 North Orange Avenue, Suite 1875, Orlando, Florida 32801, which is located in Orange County, and its initial registered agent at that office is Hal K. Litchford, Esq.

3. Purpose.

- A. To engage in every phase and aspect of the business of rendering the same professional services to the public that a physician duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through its members, managers, officers, employees, and agents who are duly licensed or otherwise legally authorized to render the same professional services under the laws of the State of Florida.
- B. To invest the funds of the Company in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional medical services, as otherwise permitted by the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes.
- C. To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Organization or any amendment thereof, necessary or incidental to the protection and benefit of the Company, and, in general, either alone or in association with other corporations, companies, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objectives or the furtherance of such purposes or objectives of the Company.

The foregoing paragraphs shall be construed as enumerating both objectives and purposes of the Company; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Company otherwise permitted by law.

- 4. **Management**. The Company will be Member Managed. The initial Managing Member of the Company is Jeffrey Sadowsky, MD.
- 5. **Principal Office.** The principal office of the Company is located at 390 North Orange Avenue, Suite 1875, Orlando, Florida 32801.

6 Existence and Duration. The Company shall commence its existence on the date these Articles of Organization are filed, and its duration shall be perpetual unless sooner dissolved by law or in accordance with provisions of the Operating Agreement.
