

CATHERINE SOPHIA RODRIGUEZ RODRIGUEZ REVOCABLE LIVING TRUST AGREEMENT

AGREEMENT made February 21, 2013 between Catherine S. Rodriguez of ORLANDO, ORANGE County, FLORIDA, (hereafter sometimes called Grantor) and Catherine Sophia Rodriguez Rodriguez of ORLANDO, ORANGE County, FLORIDA (hereafter sometimes called ATrustee@).

I. SUCCESSOR CO-TRUSTEES

The term ATrustee@ as used in this Trust means one or more Trustees as well as any Successor Trustee and Successor Co-Trustees.

A. Successors; Death of Grantor

In the event of the death, resignation, removal, or incapacity of the Grantor, CATHERINE SOPHIA. RODRIGUEZ RODRIGUEZ, then her mother, MILDRED M. RODRIGUEZ, her father FRANCISCO A. RODRIGUEZ, shall serve as Successor Co-Trustees. In the event of the death, incapacity, resignation, refusal, removal, or inability of either of the above-named Successor Co-Trustees to serve, then the Grantors her Aunt YAMELLY JOSEFINA RODRIGUEZ ALVAREZ, shall serve as a Successor Co-Trustee.

B. Delegation of Trustee (s) Duties

To the extent that the Grantor(s) mother is serving as a Co-Trustee, the Co-Trustees shall delegate to the Grantor(s) mother sole authority to make any discretionary distributions of income or principal from the Family Trust.

C. Removal of Trustee by Grantor


The Grantor reserves the right to remove any Trustee, Trustees, or Successor Co-Trustees.


