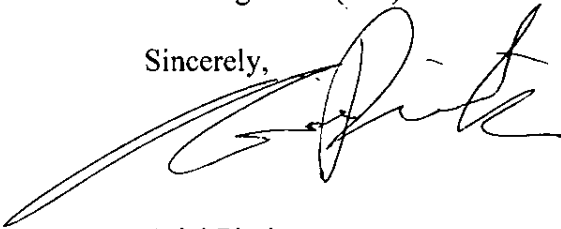

**ARTICLES OF ORGANIZATION
OF
AP MAINTENANCE SERVICES, LLC**

The undersigned certifies that I have associated myself for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of a limited liability company for profit. The following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I – NAME OF THE LIMITED LIABILITY COMPANY

The name of the limited liability company shall be:

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

This limited liability company shall have the power and authority to establish branch offices at any other place or places as the President may designate.

ARTICLE III – PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

1. To engage in any lawful activity or business authorized under the Florida Statutes and to carry on any and all incidental business without limitation.

ARTICLE IV – EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of the President of the limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by the President of the limited liability company.

ARTICLE V – BOARD OF DIRECTORS

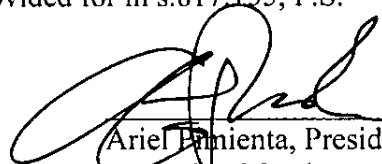
