**ARTICLES OF ORGANIZATION
OF
REHABILITATION CARE GROUP-ORLANDO, LLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be REHABILITATION CARE GROUP-ORLANDO, LLC.

**ARTICLE II
DURATION**

The term of existence of the Company shall commence with the filing of the Articles of Organization with the Secretary of State of Florida, and shall continue perpetually, unless earlier terminated pursuant to the Act or the Operating Agreement of the Company (as defined in §608.402(24) of the Act).
