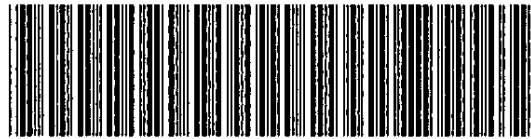

ARTICLE V - REGISTERED AGENT; REGISTERED ADDRESS


