
ARTICLE IX - MANAGEMENT



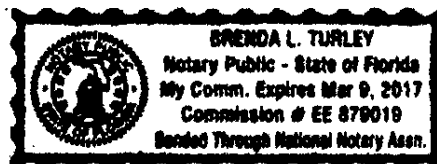
