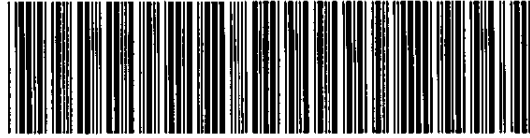

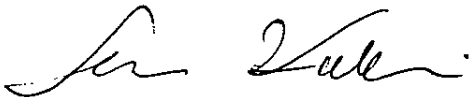
Being a start-up company, the LLC wasn't able to secure a bank loan to start
