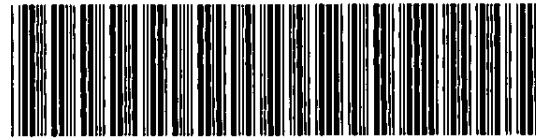

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the limited liability company is 152 Martinique, LLC (the "Company").

**ARTICLE II
ADDRESS**
