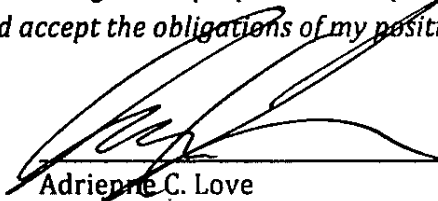

#### **Article IX – Indemnification.**

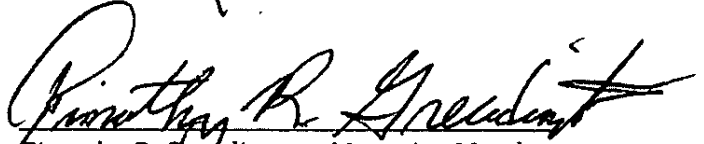

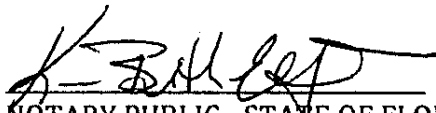
