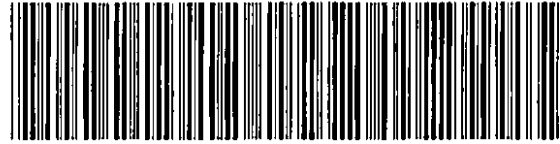

FIRST: The name of the limited liability company is COMPLETE HOME CARE – PRIVATE DUTY LLC (the “Company”).

SECOND: The Articles of Organization for this Company were filed on August 13, 2013 with an effective date of August 12, 2013, and assigned Florida Document Number L13000114324.

THIRD: The following amendment to the Articles of Organization was adopted by the Company:

Article 1 of the Articles of Organization of the Company is hereby deleted and replaced in its entirety with new Article I as follows:

The name of the Limited Liability Company is:


COMPLETE HOME CARE NURSE REGISTRY, LLC
