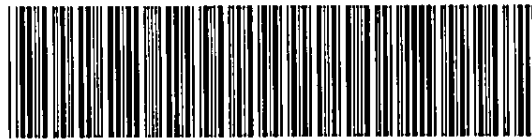

I was not notified by sunbiz or anyone else because when I added my father B. Douglas Fraley to my business Land To Sea LLC, I changed the primary address, emails and phone numbers all to be his contact information because his address was going to be the new business address as my previous address registered to my company Land To Sea LLC was not going to be good, as thoughts of selling the property is a possibility.


