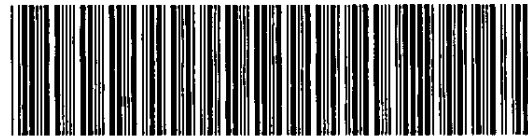


ARTICLE VI -- MANAGEMENT
