**ARTICLES OF ORGANIZATION OF
AFFORDABLE MENTAL HEALTH COUNSELING SERVICES OF SARASOTA, P.L.**

The undersigned, H. Clark West, a natural person competent to contract and member of AFFORDABLE MENTAL HEALTH COUNSELING SERVICES OF SARASOTA, P.L., hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:
