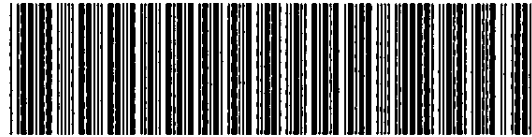


ARTICLE VII


