**ARTICLE I

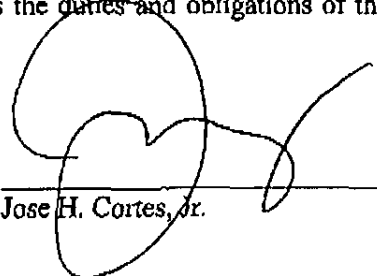
