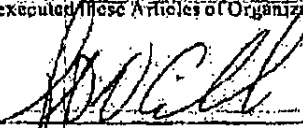
**ARTICLE III

MANAGEMENT**

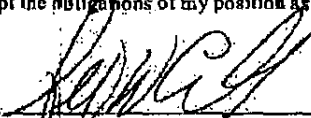
The Company shall be managed by the Manager(s) of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company shall be Seth D. Ellis.
