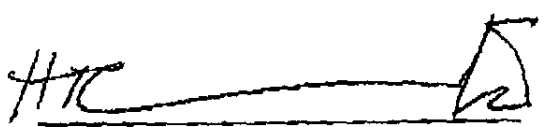
ARTICLE VI. PURPOSE

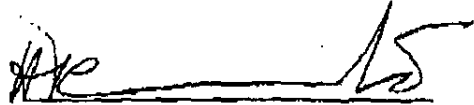
