The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the Limited Liability Company shall be PEE WEE'S BLUES GRILL, LLC.

**ARTICLE II**

**ADDRESS**

The principal place of business of the Company in Florida and the mailing address shall be 808 - 8<sup>th</sup> Avenue West, Palmetto, Florida 34221

**ARTICLE III**

**DURATION**

The Company shall commence its existence on the effective date of August 8, 2013. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization or in regulation.

**ARTICLE IV**

**REGISTERED OFFICE AND AGENT**

The name and street address of the Registered Agent of the Company in the State of Florida are LAYON F. ROBINSON, II, 442 OLD MAIN STREET, BRADENTON, FLORIDA 34205.

**ARTICLE V**

**CAPITAL CONTRIBUTIONS**

The members of the Company shall contribute to the capital of the Company the cash or property set forth in exhibit "A":

## **ARTICLE VII**

### **ADMISSIONS OF NEW MEMBERS**

#### **(TRANSFERABILITY OF INTERESTS)**

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

## **ARTICLE VIII**

### **TERMINATION OF EXISTENCE (CONTINUITY OF LIFE)**

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member of the Company, unless the business of the Company is continued by the consent of a majority in interest of the remaining members.

## **ARTICLE IX**

### **MANAGEMENT (MANAGEMENT BY MEMBERS)**

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company.

These regulations may contain any provision for the regulation and management of the affairs of the Company not consistent with law or these Articles of Organization. The name and address of the initial manager of the Company is Jasper L. Mitchell whose name and address is as stated below:

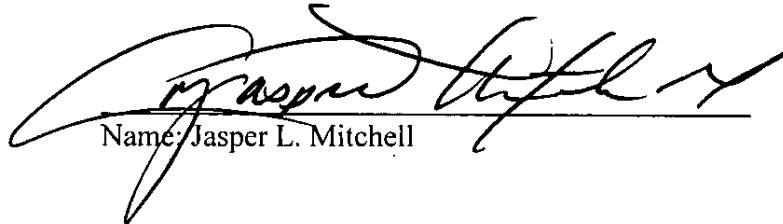
