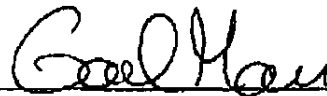

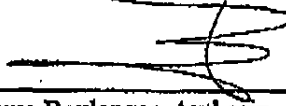
ARTICLE VI**Amendment of Articles of Organization**

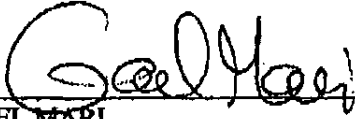
