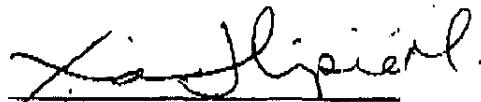
ARTICLES IX- TERMINATION OF EXISTENCE

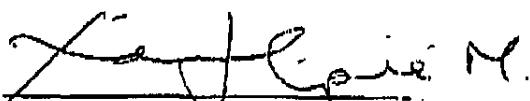
