**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION  
OF  
SAS LM PROSPECT PARK MANAGERS, L.L.C.**

The undersigned, as Manager of SAS LM PROSPECT PARK MANAGERS, L.L.C., a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), state as follows:

2. The date of the filing of the original Articles of Organization of the Company was August 29, 2013.
3. The Articles of Organization of the Company are hereby amended by deleting Article I in its entirety and inserting the following section in its place and stead:
