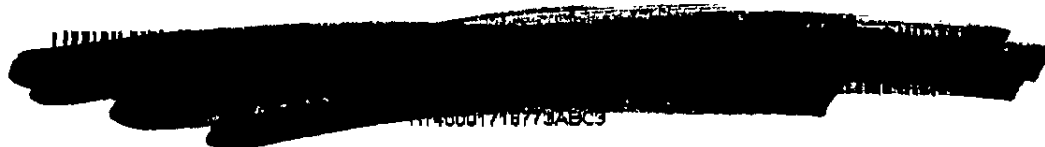

**ARTICLES OF DISSOLUTION


