ARTICLES OF ORGANIZATION

OF

ENVIRO-SPATIAL GARDENS LLC

The undersigned, for the purpose of forming a limited liability company unter the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereb makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

ARTICLE 10 - INDEMNIFICATION

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining. shall not be otherwise affected. All references in these Articles of Organization 60 "member", "manager", "employee" and "agent" shall include the heirs, estate executors, administrators and personal representatives of such persons.
