PGH FOF Investments, LLC

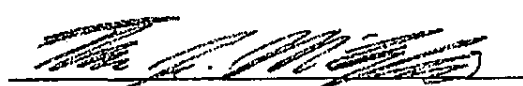

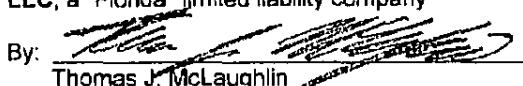
