The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or pleas of nolo contendere, or its equivalent shall not of itself, create a presumption that the person did not act in good faith and in a manner

which he or she reasonably believed to be in or at least not opposed to, the best interest of the company.

- b. The foregoing indemnification shall not apply in the case of action, suit, or proceeding instituted by one or more members of the company, if the claim, matter, or issue raised therein is determined by a court of competent jurisdiction to have resulted from the negligence or misconduct of the member(s) seeking indemnification; provided, however, that such indemnification shall nonetheless apply if, in view of all the circumstances of the case, such count shall determine that such member(s) is/are fairly and reasonable entitled to identification, with respect to such expenses, judgments, decrees, fines, penalties, and amounts paid in settlement as determined by the court
