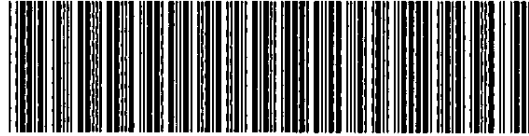

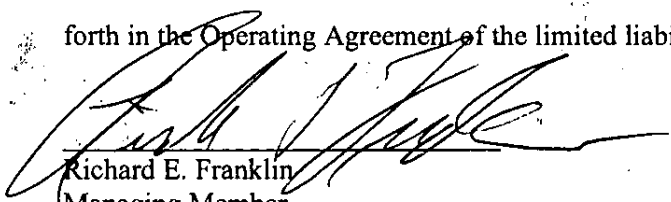

1. **Name.** The name of the limited liability company is THE POWER COOLER, LLC.
2. **Purpose.** The purpose of this limited liability company is design, manufacturing and distribution of goods and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the registered office of the limited liability company is 7621 Herricks Loop, Orlando, FL 32835.
4. **Term.** Term of this LLC shall be perpetual.
5. **Members at Time of Formation.** There will be at least one member at the time the limited liability company is formed.
6. **Period of Duration.** The period of duration shall be perpetual.
