ARTICLE V**REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the State of Florida is William F. Vengrofski, 19 Cyclamen Court West, Homosassa, FL 34446.

ARTICLE VI**CAPITAL CONTRIBUTIONS**

The initial members of the Company shall contribute to the capital of the Company the sum of \$1,000.00.
