PLACE OF BUSINESS AND REGISTERED AGENT**

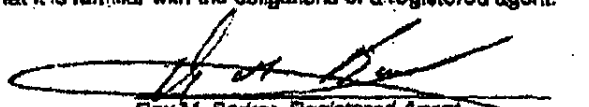

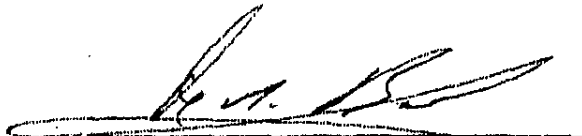

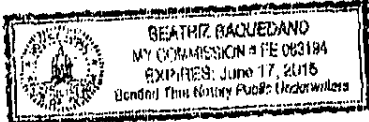
