**ARTICLES OF ORGANIZATION
OF
CULTIVA HOLDING LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Cultiva Holding LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 2 Grove Isle Drive, Penthouse 10, Building 2, Miami, Florida 33133.

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company shall be manager-managed limited liability company and shall be managed in accordance with the Operating Agreement, if any, adopted by the members for the management of the business and affairs of the Company.
