**ARTICLES OF ORGANIZATION OF
CR AUTO HOLDINGS, LLC**

The undersigned, being authorized to execute and file these Articles, hereby forms a limited liability company under the laws of the State of Florida to be known as CR AUTO HOLDINGS, LLC (the "Company").

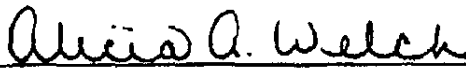
