On September 11, 2013, Naples Testosterone Clinic, LLC (the "Company"), filed its Articles of Organization with the Florida Department of State as Document Number L13000128969, which were amended via Articles of Amendment filed on September 24, 2013, were again amended via Articles of Amendment filed on November 1, 2018 and were again amended via Articles of Amendment filed on February 8, 2019.

Pursuant to the provisions of Florida Statutes Section 605.0202, the undersigned, being an authorized representative of the Company, does hereby amend and restate the Articles of Organization of the Company in their entirety as follows:

1. Name

The name of this limited liability company is T Clinics. USA of Naples, LLC (the "Company"), and it shall be formed as a Florida limited liability company under the laws of the State of Florida.

2. Duration and Purpose

The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual. The Company is organized to transact all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

3. Place of Business


