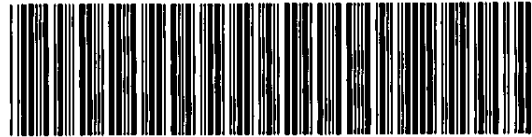

Management






