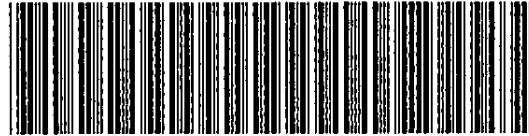

Articles of Organization

of

CIAO BELLA OF VENICE, LLC

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is **CIAO BELLA OF VENICE, LLC.**

2. **DURATION.** The period of duration of the Company shall be perpetual.

3. **PURPOSE.** The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.

4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE.**
The mailing address and street address of the principal office of the Company is: 1314 East Venice Avenue, Suite E, Venice, Florida 34285.

5. **REGISTERED AGENT.** The name and address of the initial Registered Agent of the Company is: WAYNE C. HALL, ESQUIRE, 1314 East Venice Avenue, Suite E, Venice, Florida 34285.

6. **MANAGEMENT BY MANAGER.** The Members of the Company shall not be Managers by virtue of their status as Members. The Company shall be a manager-managed limited liability company and shall be managed by a Manager appointed by the vote of a majority in interest of the Members. The name and address of the initial Manager who shall manage the Company is KAREN HALL, 1314 East Venice Avenue, Suite E, Venice, Florida 34285.

7. **ADDITIONAL MEMBERS.** New Members may be admitted only upon the unanimous written consent of the Members and in accordance with restrictions set forth in the Operating Agreement of the Company.

8. **LIMITED LIABILITY.** No Member or Manager or agent of the Company shall be liable under a judgment or decree, or order of a court, or in any other manner for any debt, obligation, or liability of the Company.

9. **CONTINUATION OF BUSINESS.** The remaining Members may, by unanimous agreement, elect to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company. No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Operating Agreement of the Company.
