**ARTICLES OF ORGANIZATION
OF

The undersigned person, acting as the authorized representative of Bayrock Oklahoma City Exchange, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

ARTICLE IX - TERMINATION OF A MEMBERSHIP INTEREST




ACCEPTANCE OF REGISTERED AGENT
