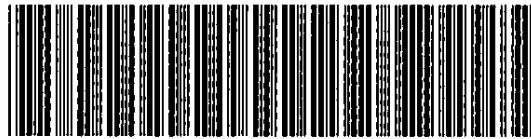

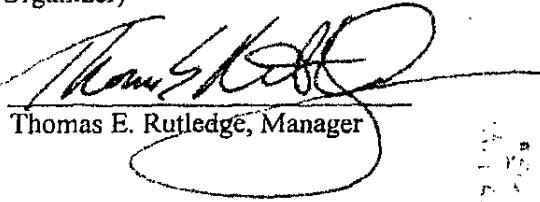
#### Article VI

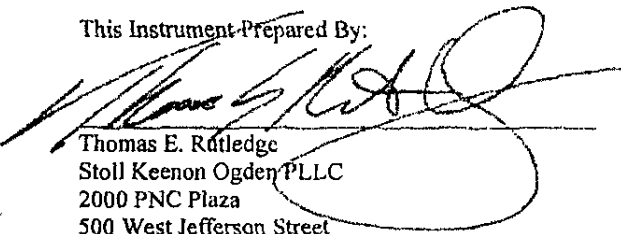
