

ARTICLES OF ORGANIZATION OF

DIXON'S FRESH OFF THE BOAT SEAFOOD, LLC

ARTICLE I

Name

The name of the Limited Liability Company is DIXON'S FRESH OFF THE BOAT SEAFOOD, LLC.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 6975 Long Moss Lane, Englewood, Florida 34224.

ARTICLE III

Duration

The period of duration of the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office
