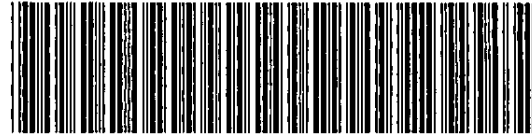

**ARTICLES OF ORGANIZATION OF

ARTICLE I

Name

The name of the Limited Liability Company is DIXON'S FRESH OFF THE BOAT SEAFOOD, LLC.

Continuation of Business



ARTICLE VIII


Additional Provisions


