ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be WHP SOLUTIONS, LLC (the "Company").

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION

ARTICLE IV -- REGISTERED OFFICE AND AGENT


