ARTICLES OF ORGANIZATION OF WHP DATA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be WHP DATA, LLC (the "Company").

ARTICLE II -- ADDRESS

The street address and mailing address of the Company shall be 9132 Strada Place, 3rd Floor, Naples, Florida 34108.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- MANAGEMENT
