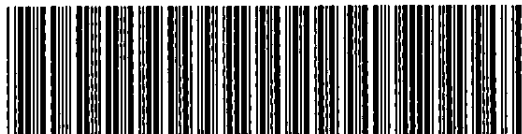

The name of this limited liability company shall be: **URIBE TROFF BUSINESS ENTERPRISES, LLC.**

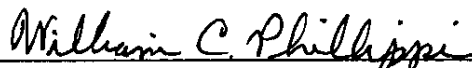
ARTICLE II
