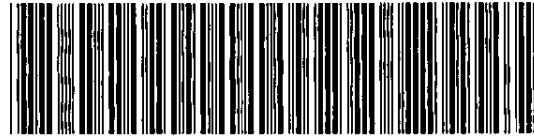

3. The name of the Company and Article I of its Articles of Organization are hereby amended so that, in lieu of their respectively current language, they shall read as follows:

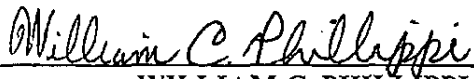
