# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF SHIM MEDIA, LLC

Pursuant to the provisions of Section 605.0202, Florida Statutes, SHIM MEDIA, LLC, a Florida limited liability company, adopts the following Articles of Amendment to its Articles of Organization, which were filed on September 24, 2013 and assigned Florida document number L13000134894.

1. The provisions of Article I of the Articles of Organization are hereby deleted in their entirety and the following inserted in lieu thereof:

# "ARTICLE I

### Name

The name of this limited liability company (the "Company") shall be:

# Entangle Media, LLC"

2. The provisions of Article V of the Articles of Organization are hereby deleted in their entirety and the following inserted in lieu thereof, and new Article VI and Article VII of the Articles of Organization are added to read as follows:

# "ARTICLE V

#### Operating Agreement

The power to adopt the operating agreement of the Company, to alter, amend or repeal the operating agreement of the Company, or to adopt a new operating agreement, shall be vested in the members of the Company. The operating agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the Jaws of the State of Florida or of the United States.
