THE FOLLOWING ARTICLES OF MERGER are submitted to merge the following Florida Limited Liability Companies in accordance with §605.1025, Florida Statutes.

FIRST: The merging party is **FINDAMEMORY.COM, LLC** (the "Merging Party"), a Florida limited liability company organized on July 17, 2007 by the filing of Document Number L07000073902.

SECOND: The surviving party is **SHIM MEDIA, LLC** (the "Surviving Party"), a Florida limited liability company organized on September 24, 2013 by the filing of Document Number L13000134894.
