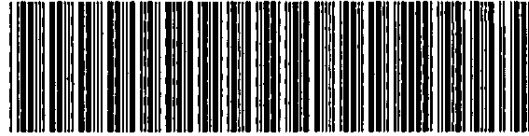



**ARTICLE I  
NAME**

The name of the limited liability company ("hereinafter "Company") is VINE'S WINE & SPIRITS, LLC.
