2. The following amendment to the Articles of Organization was adopted by the limited liability company:

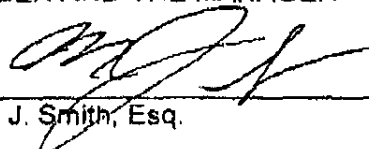
- a. Article IV is hereby deleted in its entirety and replaced with the following:
