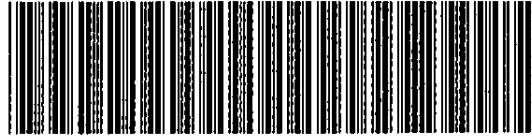

**ARTICLES OF ORGANIZATION OF
ARCTIC TRANSPORT REFRIGERATION, LLC
A Florida Limited Liability Company**

ARTICLE I

Name

The name of the limited liability company ("Company") is Arctic Transport Refrigeration, LLC.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 4354 Aqua Vista Drive, Orlando, Florida 32839.

ARTICLE III

Duration

The Company shall have a perpetual existence, unless dissolved upon the written consent of all of its members or on the occurrence of the death, bankruptcy, resignation, or expulsion of the last one of its members. If, however, within the following 90 days, the personal or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of it or its nominee as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.

ARTICLE IV

Registered Agent and Office

The name of Company's initial registered agent in Florida is Constance Ottman. The address of Company's registered office in Florida is 4354 Aqua Vista Drive, Orlando, Florida 32839.

ARTICLE V

Management

ARTICLE VI

Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

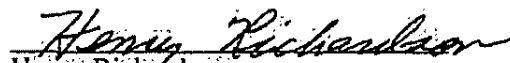
ARTICLE VIII

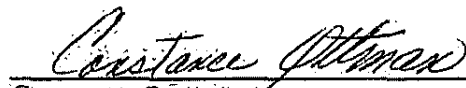
