**ARTICLES OF ORGANIZATION
OF
CAVIC PROPERTIES, LLC.**

Pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), the undersigned representative of the members, for the purposes of forming a Florida limited liability company, hereby adopts the following Articles of Organization:

**ARTICLE 1
NAME**

The name of the company is CAVIC PROPERTIES, LLC. (the "Company").

**ARTICLE 2
DURATION AND PLACE OF BUSINESS**

The period of duration of the Company is perpetual and its principal place of business is at 1627 SW 37 Avenue, Unit 405, Miami, FL, 33145. The Company may also maintain an office or offices at such other place or places, either within or without the State of Florida as may be determined, from time to time, by the Company's manager.

**ARTICLE 3
MAILING ADDRESS**

The Company's mailing address will be 9250 NE 12th Avenue, Miami Shores, FL, 33138.

**ARTICLE 4
PURPOSE**

The purposes for which the Company is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Limited Liability Company Act.

**ARTICLE 5
REGISTERED OFFICE AND REGISTERED AGENT**

The registered office of the Company shall be located at 9250 NE 12th Avenue, Miami Shores, FL, 33138, or at such location as may be determined by the Company's manager and the corporation's registered agent shall be Fabiola de Godoy Bueno.

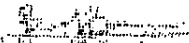
ARTICLE 7 LIMITATION OF LIABILITY OF MANAGERS AND MANAGING MEMBERS

ARTICLE 8 INDEMNIFICATION OF COMPANY'S AGENTS

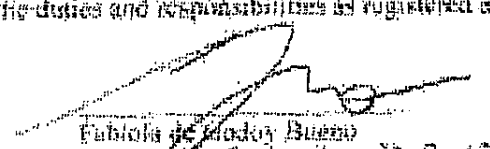
