AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF NEW RIVER AUTO MALL MANAGEMENT, LLC

The Articles of Organization of New River Auto Mall Management, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on September 30, 2013. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Peacock Management Services, LLC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - REGISTERED OFFICE AND AGENT
