ARTICLES OF ORGANIZATION  
OF

ARTICLE 1

Name

Management of the Company


The Company is to be managed by one or more managers and is, therefore, a manager-managed company. The initial manager of the Company is William D. McKnight.

Indemnification


The Company shall indemnify its managers and members to the fullest extent authorized by law.
